LIFE Association Membership Terms & Conditions

LIFE Association, Inc. (“LIFE”) provides you with benefits and services designed to enhance your life and stretch the value of your hard-earned dollars. Once a LIFE Member, a variety of Association products, services and group insurance plans are available for consideration.

Membership – Membership in LIFE Association, Inc. will be effective the date of the enrollment and collection of the first dues.

Collection of Membership Dues – LIFE Association, Inc. may collect Membership Dues or may utilize a licensed Third-Party Administrator (TPA). Selected TPA shall agree to administer its duties pursuant to all terms in the Agreement.

During the term of your Membership, your Association is required by regulators to maintain regular contact. Some of the items you may receive via email are:

- LIFE Association Quarterly Newsletters
- LIFE Association Notices of Membership Meetings
- LIFE Association Notices of Special Offers to Members

Proxy - In regard to your participation as a member of LIFE Association, Inc. (the “Association”) you appoint the Secretary of the Association in office at any particular time as your proxy to receive notice of and attend all meetings of the members and vote on your behalf and to otherwise act for you in the same manner and with the same effect as if you were personally present. This proxy shall be valid until revoked by you at any time prior to voting at any meeting, by executing and delivering a written notice of revocation to the Secretary of the Association, by executing and delivering a subsequently dated proxy to the Secretary of the Association, or by voting in person.

The Association is not an insurer, guarantor or underwriter and does not provide any products, product liability or guarantees for any Member. Providers of products and services are independent contractors and are not employees or agents of the Association. The final selection of a provider, facility or merchant and the approval or disapproval of products or services are the Member’s choice alone. The Association and its affiliates do not have the responsibility nor liability for a member or Member’s dependents.

This Agreement shall be governed and construed in accordance with the laws of the State of Texas. Any dispute or claim in law equity arising out of this Agreement or any resulting transaction, including disputes or claims involving the parties to this Agreement, their officers, agents, or employees, shall be submitted to neutral, non-binding mediation prior to the commencement of arbitration, litigation, or any other proceeding before a trier of fact. The parties to the dispute or claim agree to act in good faith to participate in mediation, and to identify a mutually acceptable mediator. If a mediator cannot be agreed upon by the parties, each party shall designate a mediator and those mediators shall select a third mediator who shall act as the neutral mediator, assisting the parties in attempting to reach a resolution. All parties to the mediation shall share equally in its cost. If the dispute or claim is resolved successfully through the mediation, the resolution will be documented by a written agreement executed by all parties. If the mediation does not successfully resolve the dispute or claim, the

mediator shall provide written notice to the parties reflecting the same, and the parties may then proceed to seek an alternative form of resolution of the dispute or claim, in accordance with the remaining terms of this Agreement and other rights and remedies afforded to them by law. Exclusive venue for such mediation shall be in Collin County, Texas. Members shall submit all grievances in writing via U.S. Mail to LIFE Association, Inc., 500 N. Central Expressway, Suite 325, Plano, TX 75074. These provisions shall survive termination of membership. This Agreement constitutes the entire Agreement between Members and the Association. There are no warranties, express or implied, other than those expressly stated herein. This Agreement may only be amended in writing by LIFE Association, Inc. which may assign its duties and responsibilities hereunder to third parties.

Release of Medical Information – By utilizing any benefit or service available through the Association, that requires medical information, Member consents to the release of any and all information related to their utilization of said benefit or service, including but not limited to medical information to the Association. LIFE Association, Inc. The 2016 Identity Fraud Study released by Javelin Strategy & Research, revealed the number of identity fraud victims was at its second highest level in six years, but the amount stolen was at its lowest point in the past six years. Identity fraud is a serious issue as fraudsters have stolen \$112 billion in the past six years. That equals \$35,600 stolen per minute, or enough to pay for four years of college in just four minutes. Fraudsters have reacted by moving away from existing card fraud to focus on new account fraud. This drove a 113 percent increase in incidence of new account fraud, which now accounts for 20 percent of all fraud losses.

Suggested Safety Tips to Protect Consumers:

- **Secure your mobile device**
As consumers transition more of their financial lives to smart phones and tablets, these devices have become high-profile targets for both cyber crooks and thieves alike. To help protect against criminals from getting their hands on valuable personal information, apply software updates as soon as they become available and take advantage of the security capabilities built into Android and iOS devices, such as protecting the device with a pass code or biometric (such as a fingerprint), and the ability to encrypt and remotely wipe the contents of the device in the event it is stolen.
- **Exercise good password habits**
Passwords have remained the de facto first line of defense for most online accounts, which has motivated criminals to compromise them whenever possible. Using strong, unique, regularly updated passwords helps reduce the value to fraudsters of passwords stolen in a data breach or through malware.
- **Take advantage of EMV and mobile payments**
Recently introduced to the U.S., EMV chip cards and mobile payment solutions (such as Apple Pay), can reduce the value of payment data to cyber thieves, as they introduce security factors which make misusing the data much more difficult when compared to traditional magnetic stripe cards.
- **Sign up for account alerts**
A variety of financial service providers, including depository institutions, credit card issuers and brokerages, provide their customers with the option to receive notifications of suspicious activity. These notifications can often be received through email or text message, making some notifications immediate, and some go so far as to allow their customers to specify the scenarios under which they want to be notified so as to reduce false alarms
- **Seek help as soon as fraud is detected**
The more immediate a financial institution, credit card issuer, wireless carrier or other service provider is notified that fraud has occurred on an account, the sooner these organizations can act to limit the damage. Early notification can also help limit the liability of a victim in some cases, as well as allow more time for law enforcement to catch the fraudsters in the act.

Choose to set fraud alerts on your credit files, reduce the amount of junk mail your family receives and get copies of your credit reports. You can also document your credit card information, driver's license and insurance policy numbers all in one safe location.

Take Control! Additional tips to safeguard your identity

Be consistent with your routine of checking. You can do a lot of it yourself. Watch your bank account statements, credit cards and other online accounts. Other signs can be:

- You see withdrawals from your bank account that you can't explain - You don't get your bills or other mail.
- Debt collectors call you about debts that aren't yours - You find unfamiliar accounts or charges on your credit report.
- Medical providers bill you for services you didn't use.
- A health plan won't cover you because your medical records show a condition you don't have.
- The IRS notifies you that more than one tax return was filed in your name, or that you have income from an employer you don't work for.
- You get notice that your information was compromised by a data breach at a company where you do business or have an account.

Discovery often comes:

- When attempting to open a savings account or college fund for the child.
- When numerous pre-approved credit card offers come in the name of the child.
- When credit cards, checks, bills or bank statements are sent in the name of the child.
- When collection agencies call or send letters about accounts not opened by the child.
- When a teen is denied a driver's license because another person has their Social Security Number as their ID.

Additional tips and information

If you suspect and have some reason to believe your child's identity has been used and you are the child's parent or court-appointed guardian, you may write the three Credit Reporting Agencies to see if there are credit reports in that child's Social Security Number. The best news would be "there is no report".

Parents can set a fraud alert for children under the age of 18 by mailing a letter of explanation. Parents will need to submit their request in writing, as federal law prohibits the credit agencies from collecting a minor's personal information via the Web. This information should be provided to each credit bureau. If a minor child already has a credit file with that agency, the organization will then set an alert and forward a copy of their credit report to the parents.

Send certified, return receipt mail and include the following items in your letter:

- A copy of the child's birth certificate
- A copy of the child's Social Security card
- Child's full name, date of birth and previous addresses for the last five years, if appropriate
- A copy of the parent's ID, Driver's License and proof of address (ie utility bill, credit card statement, etc.)
- If the requestor is a guardian, state that and include any documentation that would legally appoint you as the guardian

If you do not hear from any of the reporting companies 30 days after getting your return receipt postcard, please file a complaint with the Federal Trade Commission (877.382.4357).

Lost Document Recovery

Fraud Alerts

Set fraud alerts! A fraud alert is a notation placed in your file with the credit reporting agencies that states that suspicious activity has been discovered in your credit file, and alerts creditors that they need to contact you and verify your identity before extending credit to anyone claiming to be you.

- You may place a fraud alert in your file by notifying just one of the three nationwide consumer credit reporting companies. As soon as that agency processes your fraud alert, they will notify the other two, who then must also place fraud alerts in your file.
- Parents can set a fraud alert for children under the age of 18 by mailing a letter of explanation. Parents will need to submit their request in writing, as federal law prohibits the credit agencies from collecting a minor's personal information via the Web. This information should be provided to each credit bureau. If a minor child already has a credit file with that agency, the organization will then set an alert and forward a copy of their credit report to the parents.
- When your alert has been activated, you'll receive a confirmation in the mail from the bureau.
- Remember, you won't be able to sign up for in-store credit offers, or get instant approval for online credit applications. You'll have to go through a verification process so that the bureaus don't think it's the perpetrator opening up another card. And if you're in the process of a buying a home or a car, you'll have to let the loan officer know what's on your file so that no red flags are raised.
- If you want to remove a fraud alert, put it in writing, and write your name, social security number, current and old addresses, date of birth and send it all to the credit bureaus via certified mail.

Credit Reports

A credit report includes information on where you live, how you pay your bills, and whether you've been sued or have filed for bankruptcy. The Fair Credit Reporting Act (FCRA) requires each of the nationwide credit reporting companies — Equifax, Experian, and TransUnion — to provide you with a free copy of your credit report, at your request, once every 12 months.

- You want a copy of your credit report to help guard against identity theft. That's when someone uses your personal information — like your name, your Social Security number, or your credit card number — to commit fraud.
- Under the FCRA, both the credit reporting company and the information provider (that is, the person, company, or organization that provides information about you to a consumer reporting company) are responsible for correcting inaccurate or incomplete information in your report.
- Tell the credit reporting company, in writing, what information you think is inaccurate. Credit reporting companies must investigate the items in question — usually within 30 days — unless they consider your dispute frivolous. They also must forward all the relevant data you provide about the inaccuracy to the organization that provided the information.
- After the information provider receives notice of a dispute from the credit reporting company, it must investigate, review the relevant information, and report the results back to the credit reporting company. If the information provider finds the disputed information is inaccurate, it must notify all three nationwide credit reporting companies so they can correct the information in your file.
- When the investigation is complete, the credit reporting company must give you the written results and a free copy of your report if the dispute results in a change.

Junk Mail Reduction

You can elect to be removed from prescreened solicitations for credit and insurance offers, thereby reducing the possibility of the information getting into the wrong hands. These lists are sold by all three credit bureaus. If you choose to opt-out, you will no longer be included in these solicitation lists.

For additional junk mail reduction, we have also provided a link to a website that enables you to opt-out of specific catalog mailings and to select specific catalogs you do NOT wish to receive.

Within 60 days you should begin to see a decrease in the number of offers you receive; however, you will continue to get offers from companies you do business with, unless you tell them specifically to stop sending the offers. You may continue to receive offers from sources that do not use the Consumer Credit Reporting agencies. If you decide at a later date that you would like to start receiving these offers again, you can return to this link and opt-In again.

Credit Card & Personal Information Form

Losing your purse or wallet, or having it stolen, can be a devastating experience. Trying to remember your credit card, debit card, bank account and driver's license numbers and who to contact when they're lost or stolen can be overwhelming.

"Digital Assets," your online account information, also need protecting. It is recommended you create a master list of online accounts and passwords and store it in a secure location, using the form provided. This information should not be included in your will as this will become public information.

We will also protect you from any liability that results from the fraudulent misuse of your lost or stolen cards up to \$50 per card up to a maximum of \$250.*

Things to do before losing your wallet

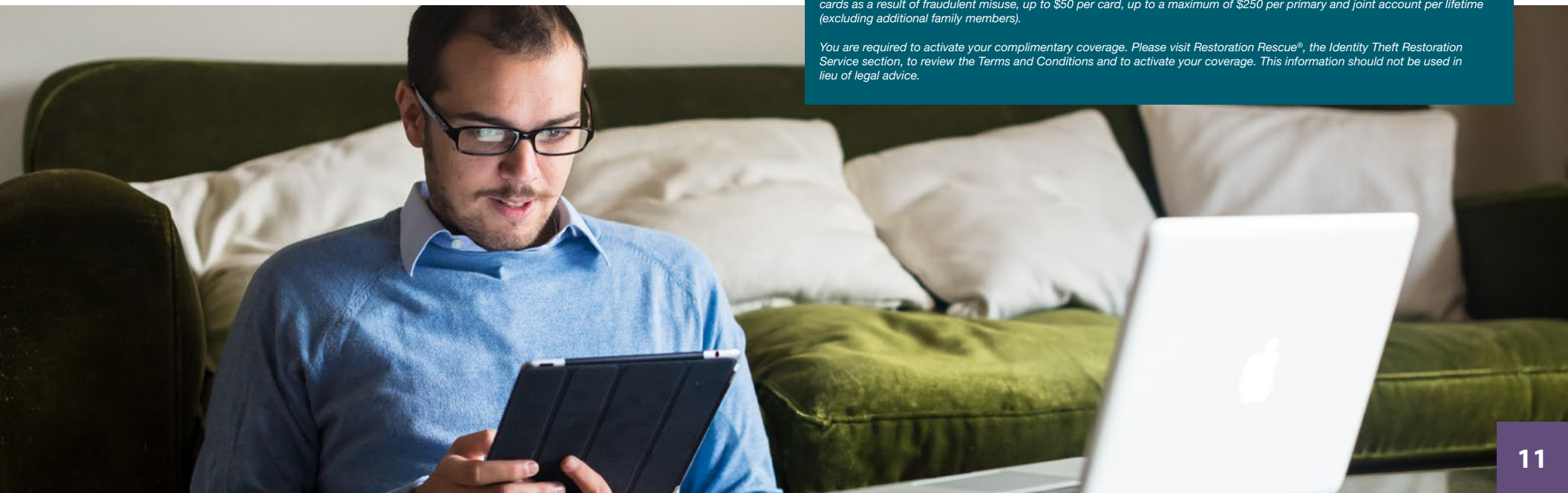
- Fill out our Credit Card & Personal Information Form and keep it in a safe place (not in your wallet).
- Put away some backup cash where you can access it if you're stranded without your ATM card.
- Put your social security card in a secure place (not in your wallet).
- Remove any information associated with your PIN numbers or passwords.

Things to do after you lose your wallet

- Take action quickly.
- Call your bank immediately and report that your ATM/Debit card has been stolen; after two business days your liability will increase.
- Call your credit card companies. Try to tell them where, when, and the amount of your last charge.
- Get your license replaced as soon as possible.
- File a police report in the jurisdiction where your credit card was stolen.
- Call the credit reporting agencies. If you haven't already put the free 90-day fraud alert on your file, now is the time!
- Equifax 1-800-525-6285; Experian 1-888-397-3742; TransUnion 1-800-680-7289.
- If your Social Security card was in your wallet, call their fraud line at 1-800-269-0271 or [download and fill out the SS-5 form](#). You are entitled to a free replacement.

Documents needed to take a cruise!!!

U.S. Citizens on closed-loop cruises will be able to enter or depart the country on the cruise with proof of citizenship, such as an original or copy of his or her birth certificate (issued by the Vital Records Department in the state where he or she was born) and, if 16 or older, a government issued photo ID. The United States does not require you to have a passport. (A Consular report of Birth Abroad issued by the Department of State or a Certificate of Naturalization is also acceptable.)

Most cruises beginning and ending in the U.S. are considered "Closed Loop," meaning they begin and end at the same port in the U.S. For instance, if you board a cruise ship at Fort Lauderdale, Florida, and after visiting at least one foreign port of call, such as Bermuda, or Cancun, return back to Fort Lauderdale, you have taken a closed loop cruise.
